WHEREAS, the Village Board of the Village of Alexander has also received a proposed Engagement Agreement from Attorney Timothy Delahunt of Delahunt Law PLLC for coverage counsel relative to the captioned matter: *C & D Design, Build, Development, LLC v. Village of Alexander, New York, et al (Index No. E65440)*; and

**WHEREAS**, the Village Board of the Village of Alexander has had an opportunity to review the proposed engagement, and finds the terms to be agreeable; and

**WHEREAS**, the Village Board of the Village of Alexander finds it to be in the best interest of the Village to enter into agreements with both Rupp Pfalzgraf and Delahunt Law for the legal assistance.
